

THE HUMBLE PETITION OF JOHN KOFI HALM SHOWS AS FOLLOWS:

---

1. The Petitioner was the candidate of the National Democratic Congress (NDC) in the 2024 Parliamentary Election held in the Trobu constituency on 7<sup>th</sup> December, 2024
2. The 1<sup>st</sup> Respondent was a candidate of the New Patriotic Party (NPP) in the parliamentary election held in the Trobu Constituency on 7<sup>th</sup> December, 2024 and was declared the Member of Parliament elect.
3. The 2<sup>nd</sup> Respondent is the Electoral Commission of the Republic of Ghana with the duty and mandate to enforce and administer all laws and regulations relative to the conduct of elections and referendums.
4. The 3<sup>rd</sup> Respondent is the District Office of the Electoral Commission in the Trobu Constituency.
5. The 4<sup>th</sup> Respondent is the Clerk of the Parliament of Ghana.
6. On the 7<sup>th</sup> day of December, 2024, the Electoral Commission of Ghana and the 2<sup>nd</sup> Respondent herein, conducted Parliamentary elections in the Trobu Constituency of the Greater Accra Region of Ghana
7. At the end of the election, the 2<sup>nd</sup> Respondent declared the 1<sup>st</sup> Respondent, Madam Gloria Owusu (candidate of the National Patriotic Party), as the winner of

the election and, by extension, the Member of Parliament elect for the Trobu constituency.

**8. NATURE OF THE PETITIONER'S CLAIM**

THE PETITIONER CLAIMS THAT THE PARLIAMENTARY ELECTION HELD IN THE TROBU CONSTITUENCY ON 7<sup>TH</sup> DECEMBER 2024 WAS INVALID FOR THE FOLLOWING REASONS:

- a. That there are irregularities and inconsistencies contained in FORM 8A (Regulation 32 (7) and 39(2) Statement of Polls for the Office of Member of Parliament (Pink Sheet) for **Ninety-eight (98)** polling stations out of a total of **Two hundred and eighty-eight (288)** polling stations in the Trobu Constituency.
- b. That the parliamentary election held in the Trobu Constituency on 7<sup>th</sup> December 2024 was not conducted in compliance with Regulations 39 of the Public Elections Regulations, 2020 (C.I. 127) and the principles laid down by Regulations 39 and that the said non-compliance affected the results of the elections.

#### 10. NATURE OF RELIEFS SOUGHT

WHEREFORE THE PETITIONER PRAYS AS FOLLOWS:

- a. A declaration that the Parliamentary Election held in the Trobu Constituency on 7<sup>th</sup> December, 2024 was void by virtue of the irregularities and inconsistencies contained in FORM 8A (Regulation 32 (7) and 39(2) Statement of Polls for the Office of Member of Parliament (Pink Sheet) for **Ninety-eight (98)** polling stations out of a


total of **Two hundred and eighty-eight (288)** polling stations in the Trobu Constituency.

- b. A declaration that the irregularities and inconsistencies contained in FORM 8A (Regulation 32 (7) and 39(2) Statement of Polls for the Office of Member of Parliament (Pink Sheet) for **Ninety-eight (98)** polling stations out of a total of **Two hundred and eighty-eight (288)** polling stations in the Trobu Constituency have so extensively prevailed and have reasonably affected the result of the election held in the Trobu Constituency on 7<sup>th</sup> December, 2024.
- c. A declaration that the non-compliance with Regulations 39 of the Public Elections Regulations, 2020 (C.I. 127) affected the parliamentary election results of **Ninety-eight (98)** polling stations out of a total of **Two hundred and eighty-eight (288)** polling stations in the Trobu Constituency held in the Trobu Constituency on 7<sup>th</sup> December, 2024.
- d. An order setting aside the declaration of the parliamentary election results affecting the **Ninety-eight (98)** polling stations out of a total of **Two hundred and eighty-eight (288)** polling stations in the Trobu Constituency by the 2<sup>nd</sup> and 3<sup>rd</sup> Respondents given on the 8<sup>th</sup> of December, 2024.
- e. An order directed at the 2<sup>nd</sup> and 3<sup>rd</sup> Respondents to conduct a re-run of the parliamentary elections in the affected **Ninety-eight (98)** polling stations out of a total of **Two hundred and eighty-eight (288)** polling stations in the Trobu on a date determined by the court.
- f. An order of Interlocutory Injunction directed at the 4<sup>th</sup> Respondent restraining the 4<sup>th</sup> Respondent from swearing in the 1<sup>st</sup> Respondent as Member of Parliament of the Trobu Constituency on the 7<sup>th</sup> of January 2025.
- g. An order of Interlocutory Injunction restraining and preventing the 1<sup>st</sup> Respondent from holding herself out as Member of Parliament of the 4<sup>th</sup> Republic of Ghana until the final determination of this suit.



- h. An order of Interlocutory Injunction restraining and preventing the 1<sup>st</sup> Respondent from having access to the Chamber of Parliament until the final determination of this suit.
- i. An order of Perpetual Injunction restraining the 1<sup>st</sup> Respondent from holding herself out as Member of Parliament of the 4<sup>th</sup> Republic of Ghana.
- j. An order of Perpetual Injunction restraining and preventing the 1<sup>st</sup> Respondent from having access to the Chamber of Parliament.
- k. Any other order(s) that this Honourable Court may deem fit to award.
